SCHOLARSHIPS ARE AWARDED ON A YEARLY BASIS AND FAMILIES MUST RE-APPLY EACH YEAR.

SCHOLARSHIPS ARE ONLY AWARDED TO STUDENTS IN KINDERGARTEN THROUGH 12TH GRADE AND VARY IN AMOUNTS DEPENDING ON FINANCIAL NEED.

THE FOLLOWING CRITERIA FOR AWARDING SCHOLARSHIPS ARE GIVEN EQUAL CONSIDERATION:

- FINANCIAL NEED
- ACADEMIC AND PERFORMANCE BASED MERIT
- FAMILY CIRCUMSTANCES
- NUMBER OF PEOPLE IN THE HOUSEHOLD
- AVAILABILITY OF CLASS OPENINGS
